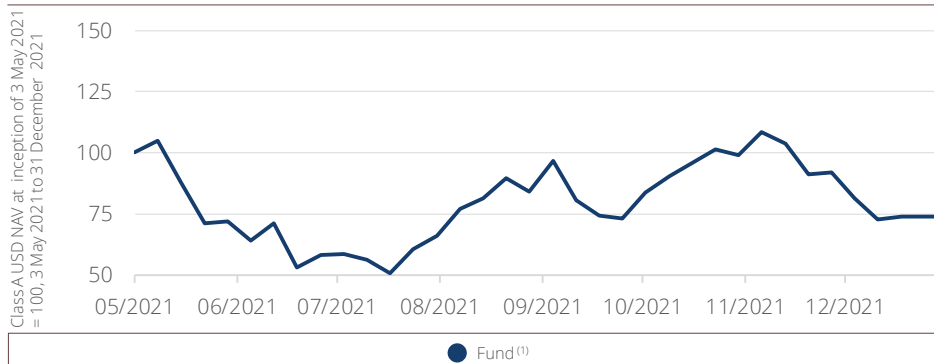
Investment Objective

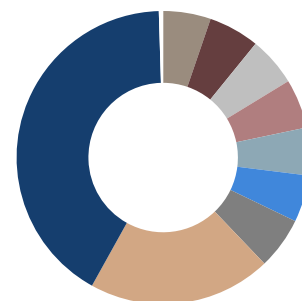

Constituents

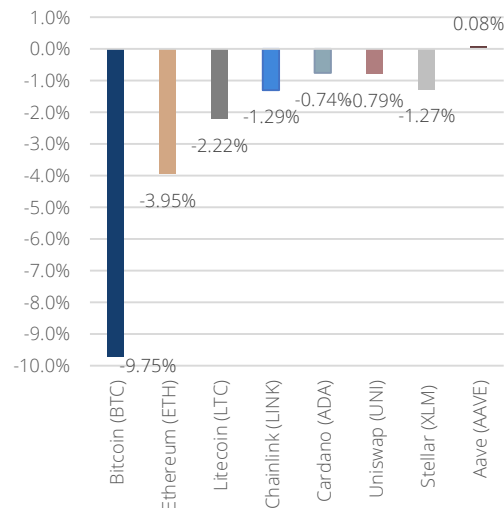
Constituents are selected on a discretionary basis within predefined criteria: with importance being placed on market capitalisation and return potential among others. Bitcoin and ether are currently the two largest crypto assets by market capitalisation; thus accounting for the largest part of the portfolio. The rest consists of smaller, yet still well established and prospective assets within the crypto space. On a quarterly basis, the constituents are re-evaluated and re-balanced in line with market developments; thus giving the portfolio time to perform and allowing it to evolve with the rise of digital assets.
